
Because of deadline constraints coverage of the Area 3 meeting on April 27 in Forrest City will be featured in the July issue of the ASO Newsletter!

From the ASO Educational Legislation Committee:

New Grant Opportunities Established Through Legislation

With the passage of the LEARNS Act, Arkansas is doubling down on its commitment to supporting the literacy outcomes of students statewide. The Arkansas Division of Elementary and Secondary Education (DESE) is launching the Arkansas Literacy Tutoring Grant Program, a new program that will provide thousands of families up to \$500 which can be used towards literacy tutoring services for eligible K-3 students.

Program Overview

Arkansas's Literacy Tutoring Grant Program established under the LEARNS Act provides \$500 grants for grades K-3 public school and open-enrollment public charter students who are at risk of reading difficulties, do not meet the reading standard as determined by the state assessment, or students who were retained in third grade. The grant will help to purchase from an approved provider either literacy tutoring services or digital literacy applications.

Under LEARNS, districts are required to notify families of their student's eligibility for the program. This document includes guidance on how districts should notify families that their children are eligible for this opportunity.


